Gary and Diane Kilpatrick inquired about the status of lines. Paul Scherrer informed that over 200 feet was utilized by Root-X which causes a foam action resulting in dying out the root issue.

Paul Scherrer said not all the lines have been done at once, however, they are just focusing on the problem areas for now.

Paul Scherrer informed residents that the pump houses have a 1,2,3 step system where each pump will come on when levels rise and when the light is red it will shut off.

Paul Scherrer expressed that they are still having issues with residents continuing to flush wipes and tampons.

Discussion took place regarding all members up for election; John Ossenfort made a motion for all members up for election to stay; Don Kansteiner seconded the motion; motion carried.

Mrs. Kansteiner inquired about the coding on the liner; Scott Moore explained that the liner is still holding good after inspection, but the board will continue to monitor.
